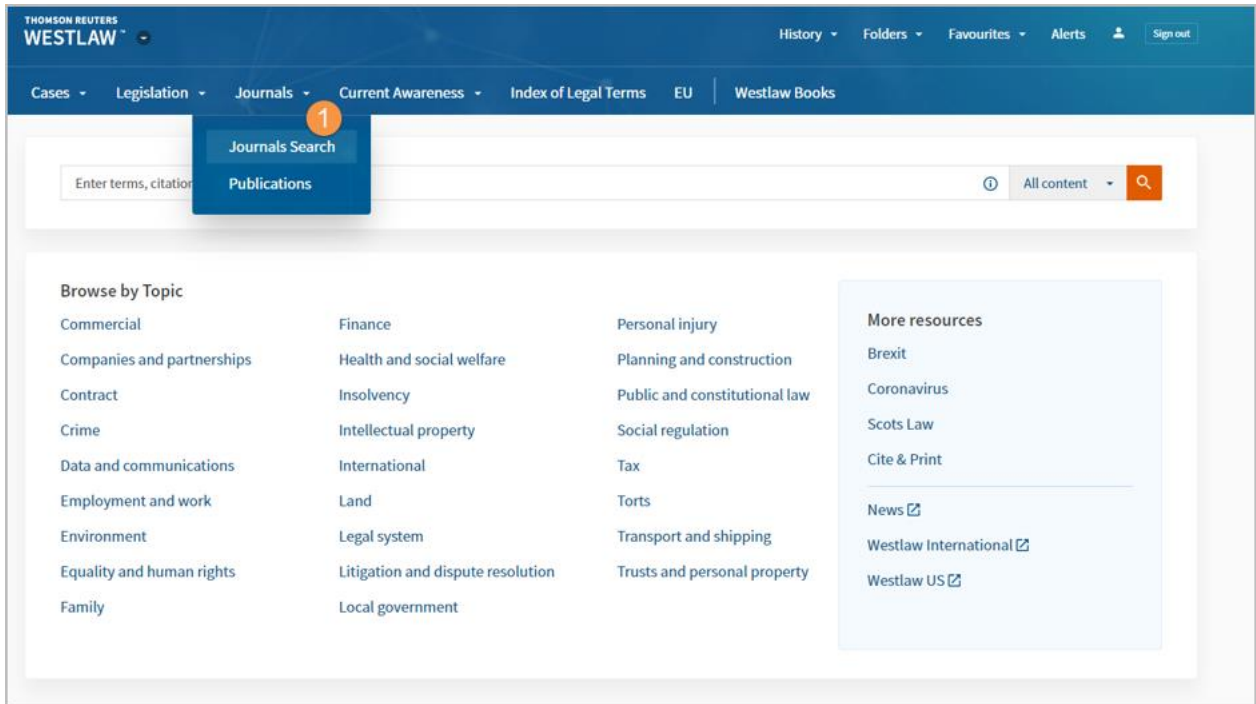


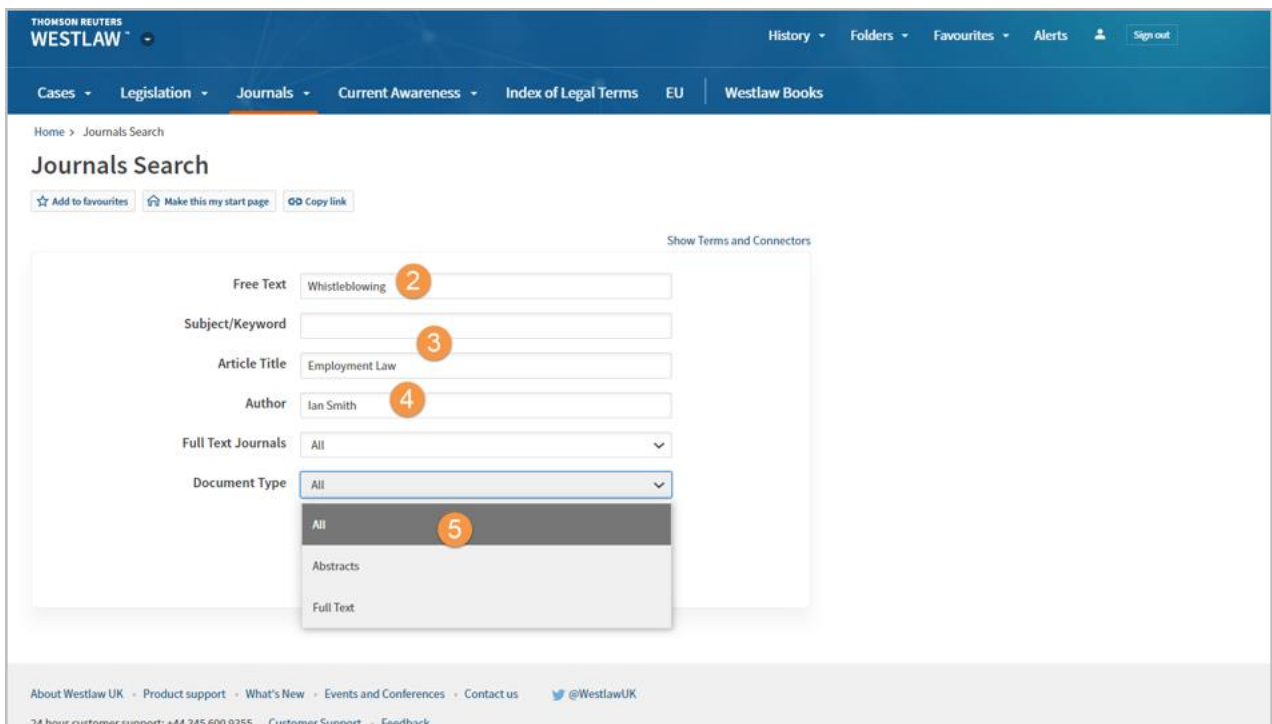
Journals Search

The Westlaw UK Journal Search template allows you to search quickly and efficiently for Journals.

1. Select Journals from the top toolbar. Choose the Journals Search option.



2. In the Free Text field, enter a keyword or phrase e.g., Whistleblowing. Terms and Connectors can be used.
 3. Alternatively, search by subject or article title.
 4. If you know the author's name, you can search using the Author field.
 5. You can choose to search within Full Text or Abstracts of a journal.
- Note: Not all journals are available in full text.



6. Your search results are displayed and sorted by date order.
7. The results display additional information about the journal including availability, author, citation, subjects, and keywords.
8. Click the Edit search button to modify your search.
9. Use the delivery tools to create an alert, increase or decrease the amount of information displayed in your search results, send a link, save to a folder within Westlaw UK, or email, print, or download your results.
10. Use the Search within results field to narrow your results by keyword or phrase.
11. Filter your search using the options on the left-hand side, including topic, Jurisdiction, date, or document type.
