The generative AI relies on enhanced searching of Practical Law UK's trusted content and returns an overview with detailed insights from your top results along with a list of key Practical Law UK content.

About Search & Summarise

Search & Summarise uses what is known as retrieval augmented generation (RAG) which limits errors by grounding the language model in Practical Law's trusted content to help ensure that all citations and links are valid because we force the AI to use Practical Law UK content to answer the question.




This technology will save you a tremendous amount of time, but it is not infallible. Search & Summarise should be part of, not a complete substitute for, your traditional research process.




Search & Summarise Guide

Running a Search & Summarise Query

- 1. Click the Tools icon in the top toolbar.
- 2. Select Search & Summarise from the side menu to access the Al Assisted research screen.



3. Type your query into the "Ask a Question" search box and click submit. Your query will now be run. This search will take longer than a typical keyword search query as Search & Summarise is processing and discovering a lot more relevant materials and then taking the most relevant results to the large language model.




- 4. Once the query has run, a summary response is generated.
- 5. Supporting authority from Practical Law UK is provided to verify statements in the AI summary. The citations are hyperlinked in the numbered brackets. Hover over a bracketed number and a pop-up will appear with the relevant excerpt from the resource.
- **6.** You can ask a follow-up question on the same issue to further refine or clarify your research. Note: Up to 5 follow-up questions is permitted.
- 7. Delivery options are displayed in the top right-hand corner.
- 8. The ability to Ask a new question on a new issue is displayed in the top right-hand corner.

9. Your most recent Search & Summarise history can be accessed by clicking the history icon on the left-hand pane, and your full Search & Summarise history can then be accessed by clicking on "Go to full history". Alternatively, you can navigate to the History Centre.
